ITVT was used for youth and children to learn to use communication technology (mobile phones, laptops, video calls) so that we continue our support during Covid-19 Pandemic times(as these children were subjected to outside curfews and lockdowns). AC was used for youth (18 years +) so that they are offered lodging and boarding (on need basis) so that they can continue further studies or get ready for employability jobs. -----
